Benefits in detail

Death Benefit

In case of unfortunate demise of the Insured Member during the Policy Term, the Base Sum Assured as Base Cover Death Benefit shall be payable to the beneficiary. If the member has opted for in-built Accidental Death Benefit (ADB) cover, then an additional amount equal to the ADB Sum Assured shall be payable in case of Accidental Death. Upon payment of the Death Benefit all the risk cover of the Member shall be terminated.

Accidental Total and Permanent Disability (ATPD) Benefit

- On occurrence of ATPD, the ATPD Sum Assured will be payable and ATPD cover shall terminate.
- Total Permanent Disability shall mean disablement of the insured member which meets the definitions in either of parts A or B as defined below:

Part A: Unable to work:

Total and Permanent Disability shall mean when the insured member is totally, continuously and permanently disabled as a result of injury due to accident and is thereby rendered totally incapable of being engaged in any work or any occupation or employment for any compensation, remuneration or profit.



Part B: Physical Impairments:

The insured member suffers an injury due to accident resulting in total and irrecoverable loss of:

1. The use of two limbs at or above wrists or ankles; or
2. The sight of both eyes; or
3. The use of one limb at or above wrists or ankles and the sight of one eye; or
4. By severance of two or more limbs at or above wrists or ankles; or
5. Sight of one eye and loss by severance of one limb at or above wrist or ankle.

The above disabilities under Part A and Part B (for loss of use of limb/s or sight as defined in point 1 to 3 above) must have lasted, without interruption, for at least six consecutive months and must, in the opinion of an appropriate medical practitioner appointed by the Company, be deemed permanent. However, the ATPD claim will be admitted even if the period of mentioned disabilities for consecutive 6 months expires after the policy term provided the date of accident is within the policy term.

For disabilities defined in point 4 and 5 of Part B above, the claim will be paid immediately.

Note – The term ‘beneficiary’ mentioned above means nominee/assignee/legal heir of the member.

However, in case the Master Policy is issued under Lender-Borrower category, the Insured Member shall have an option to issue an authorization in favor of the Company to the effect that in the unfortunate event of Insured Member’s death during the Coverage Term, the claim amount, if any payable under the Master Policy shall first be utilized for payment to Master Policyholder for the outstanding loan amount as specified in Master Policyholder’s Credit Account Statement and the balance amount, if any, payable under the Master Policy shall be paid to Nominee. This option shall however be applicable only for certain categories of Master Policyholders.

The eligible categories of Master Policyholders are Reserve Bank of India (RBI) regulated Scheduled Commercial Banks, NBFC’s having certificate of registration from RBI, National Housing Bank (NHB) regulated Housing Finance Companies, National Minority Development Finance Corporation (NMDFC) and its State Channelizing Agencies, Small Finance Banks regulated by RBI, Mutually Aided Cooperative Societies formed and registered under the applicable State Act concerning such Societies, Microfinance companies registered under section 8 of the Companies Act, 2013 and any other category as approved by the Authority.



However, in case of Master Policyholder who does not fall under the specified categories, then on the unfortunate event of Insured Member's death during the Coverage Term, the claim amount shall be payable to Insured Member's Nominee.

Wellness Services

Depending on the scheme rules defined by the Master Policyholder, members of the scheme will be eligible for wellness services (not limited to) like Tele Consultations, Preventive Health Check-Up, Diet and Nutrition Consultations etc. at no additional premium.

These Wellness Services can be availed by the Policyholder/Life Assured, from the service providers registered with Us. The availability of services shall be at our discretion. These services will be subject to the terms and conditions of the third-party service provider and at the sole responsibility of the Policyholder/Life Assured.

The above service is provided subject to the terms and conditions, and in the manner prescribed below:

- a. These services are optional services offered at no additional cost to the Member.
- b. The value of the wellness services availed by the member shall be limited to the single premium of the respective member.
- c. These services shall be directly provided by the service providers with no participation of the company.
- d. The services are being provided by third-party service provider/s, and the company shall not be liable for any liability.
- e. The company can choose to commence/discontinue the service/s or change the service provider/s at any time.
- f. The list of services provided can be updated time to time depending on the arrangement made by the third-party vendor.
- g. Cash payment in lieu of the service is not available.

Maturity Benefit

There is no maturity benefit under any of the schemes.

Modal Factors

The modal factors for Half-yearly, Quarterly and Monthly premium payment mode are 0.52, 0.265 and 0.09 respectively. These factors are multiplied to the Yearly premium to arrive at the premium for the respective mode.

Surrender Value

This is a pure protection plan hence there is no surrender value. In case of surrender of the group Policy, the Company shall give an option to individual members of the group, on such surrender, to continue as an individual Policy and the Company shall continue to be responsible to serve such members till their coverage is terminated, provided the due premium for the remaining tenure is paid.

Free Cover Limit

The Free Cover Limit will only be applicable to Employer-Employee Schemes. This is a limit on insurance cover to an individual member. Up to this limit, no evidence of health is required and acceptance of coverage will be automatic for all Members. Above the FCL, the acceptance will be subject to medical evidence as per the Company underwriting rules.

The Free Cover Limit will depend on Group size and average Sum Assured of the particular Group Scheme.



Joiners and Leavers

The Policyholder must inform the Company about the details of the exiting members as and when they exit so that the Company would terminate the risk cover for those members. Also the Policyholder should inform the Company in respect of any new entrants in the scheme along with the proportionate premium for the remaining term and other requirements, if any, as decided by the Company from time to time. In case of an Employer-Employee Scheme, in the event of a member rejoining the Scheme, such member would be treated as a new entrant under the scheme.

Tax Benefits

Premiums paid under this plan may be eligible for tax exemptions, subject to the applicable tax laws and conditions. Income tax benefits under this plan, if any, shall be applicable as per the prevailing Income Tax Laws and are subject to amendments from time to time. Kindly consult a tax expert.

Goods and Services Tax (GST) and other levies, as applicable, will be extra and levied as per prevailing tax laws and are subject to change from time to time.

Grace Period

A grace period of 30 days in half-yearly mode and quarterly mode and 15 days in case of monthly mode is applicable under this product. There is no grace period applicable in case of yearly mode. If the company does not receive the premium due within the grace period, the policy will lapse at the expiry of the grace period. In case of death of a member(s) during the grace period, the death benefit will be entertained, if the premium due for the scheme has been paid by the Master Policyholder before the end of the grace period.



Revival

You can revive the group scheme by paying the appropriate premium up to a period of 3 months from the date of first unpaid premium till the next Policy Anniversary and within the Policy Term of one year. The scheme may be underwritten afresh depending upon the period for which the Policy has been in lapse state. Please note that after the expiry of Policy Term of one year this Policy may be re issued on similar terms and conditions.

Revival of a scheme would be made in accordance with the changes in the group profile. All premiums / Sum Assured shall be determined afresh based on the current risk profile for the scheme under consideration.

Suicide Clause

In case of Non-Mandatory schemes (i.e. where member participation in the scheme is voluntary)

If the Insured Member dies due to suicide, whether sane or insane, within 12 months from the date of joining the scheme or date of revival, 80% of total premiums paid till the date of death in respect of the Insured Member shall be paid to the Nominee provided the policy is in force.

In case of Mandatory/Renewal schemes:

If the Insured Member dies due to suicide, whether sane or insane, within 12 months from the date of joining the scheme or date of revival, the Base Sum Assured shall be paid to the Nominee provided the policy is in force.

Termination of Cover

The cover would cease from the date of termination of the coverage in accordance with the scheme rules.



Nomination and Assignment

Nomination in this policy is allowed as per Section 39 of Insurance Act, 1938 as amended from time to time. Assignment in this policy is allowed as per Section 38 of Insurance Act, 1938 as amended from time to time.

Free Look Cancellation:

You will have a period of 30 days from the date of receipt of the Policy document to review the terms and conditions of the Policy and if you disagree to any of these terms and conditions, you have an option to return the Policy stating the reasons for objection. On receipt of the letter along the Policy documents, the Company will refund the premiums paid, subject to the deduction of proportionate risk premium for the period on cover and any expenses incurred by the Company on medical examination of the members and stamp fees charges, if any.

In case of Non Employer-Employee Scheme, Individual Member can also opt for free-look cancellation within 30 days of the receipt of the Certificate of Insurance.



Section 41 of the Insurance Act 1938: Prohibition of rebate, (as amended from time to time):

No person shall allow or offer to allow, either directly or indirectly, as an inducement to any person to take out or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectuses or tables of the insurer.

Section 45 of the Insurance Act 1938, (as amended from time to time):

Fraud and mis-statement would be dealt with in accordance with provisions of Section 45 of the Insurance Act, 1938, as amended from time to time. V).Insurance Ombudsman:

The office of the Insurance Ombudsman has been established by the Government of India for the redressal of any grievance in respect of life insurance policies.

Any person who has a grievance against an insurer, may himself or through his legal heirs, nominee or assignee, make a complaint in writing to the Insurance Ombudsman within whose territorial jurisdiction the branch or office of the insurer complained against or the residential address or place of residence of the complainant is located.

The complaint shall be in writing, duly signed by the complainant or through his legal heirs, nominee or assignee and shall state clearly the name and address of the complainant, the name of the branch or office of the insurer against whom the complaint is made, the facts giving rise to the complaint, supported by documents, the nature and extent of the loss caused to the complainant and the relief sought from the Insurance Ombudsman.



You may approach the Insurance Ombudsman if your grievance pertains to any of the following:

- a) Delay in settlement of claim beyond the time specified in the regulations, framed under the Insurance Regulatory and Development Authority Act, 1999
- b) Any partial or total repudiation of claims
- c) Disputes over premium paid or payable in terms of insurance policy
- d) Misrepresentation of policy terms and conditions
- e) Legal construction of insurance policies in so far as the dispute relates to claim
- f) Policy servicing related grievances against insurers and their agents and intermediaries
- g) Issuance of Life insurance policy, which is not in conformity with the proposal form submitted by the proposer
- h) Non-issuance of insurance policy after receipt of premium
- i) Any other matter resulting from the violation of provisions of the Insurance Act, 1938 or the regulations, circulars, guidelines or instructions issued by the IRDAI from time to time or the terms and conditions of the policy contract, in so far as they relate to issues mentioned at clauses (a) to (f)

No complaint to the Insurance Ombudsman shall lie unless

(a) The complainant has made a representation in writing or through electronic mail or online through website of the insurer or insurance broker concerned named in the complaint and—

(i) Either the insurer or insurance broker, as the case may be, had rejected the complaint, or

(ii) The complainant had not received any reply within a period of one month after the insurer or the insurance broker, as the case may be, received his representation, or

(iii) The complainant is not satisfied with the reply given to him by the insurer, or the insurance broker, as the case may be.

(b) The complaint is made within one year—

(i) After the order of the insurer or insurance broker, as the case may be rejecting the representation is received, or

(ii) After receipt of decision of the insurer or insurance broker, as the case may be, which is not to the satisfaction of the complainant, or

(iii) After expiry of a period of one month from the date of sending the written representation to the insurer or the insurance broker as the case may be, if the insurer or insurance broker, as the case may be, named fails to furnish reply to the complainant.
